DTPC invites suitably experienced and accredited service providers to supply, deliver, install, commission and maintain the following equipment:

- A large tunnel, Dual view X-Ray Machine capable of screening palletized cargo, and smaller cargo / baggage.

*The minimum tunnel size should accommodate an AKE ULD; Preference would be a tunnel size closer to 2000mm in height and 2000mm in width.*

- A handheld explosive trace detection devices that are capable of identifying a large array of narcotics in addition to various categories of explosives.

The purpose of the equipment is to effectively screen cargo tendered for carriage by air, and thus need to meet applicable legislated requirements and standards, including South African Civil Aviation Authority approval, TSA approval and EU and UK standards.

### EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system.
