Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC has completed landscaping of specific areas around the King Shaka International airport (KSIA) access road and other DTPC facilities. DTPC intends to appoint a service provider who will provide DTPC with a comprehensive landscaping maintenance services for these areas (covering around 75ha of landscaped area which includes grass, general landscaping plants and hard landscaping).

The Maintenance responsibility by the service provider will include, but not limited to the following completed landscaping areas:

- TradeZone; Access Roads; Dube City; AgriZone; Link Road and, DTPC Fence Line

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 preference point system where 90 points will be reserved for price only and 10 points reserved for preference points as per the B-BBEE verification certificates or EME letters.
